MEMBERSHIP RULES AND REGULATIONS

→ Lines 5 must be initialed.

1. Members may use Jessy's during any operating hours by appointment only.
2. Members are not allowed to bring guests to use their allotted time slot.
3. Members are required to show their ID card each time they enter the facility.
4. Members who allow other persons to use their membership card will have their membership privileges revoked.
5. Memberships are not refundable or transferable. Lost ID cards may be replaced with this receipt and a \$15.00 charge will be added.
6. Members will receive a 70% discount on all in-house menu items. (see membership menu)

1. **INITIATION FEE AND DUES.** In consideration of your MEMBERSHIP you are paying a non-refundable, non-transferable, one time initiation fee of **\$ 49.00** and a non-refundable monthly fee will be **\$49.00** If you agree to pay dues, in advance, for the first full calendar year your MEMBERSHIP will be discounted an additional 5%. Your dues will begin when this Agreement is signed and will continue unless otherwise terminated, and the remaining MEMBERSHIP fees will be charged to your account. You have _____ have not _____ elected to prepay one year's dues in the amount of \$ _____ per month times 12. If you have elected not to prepay, we will deduct the above monthly charge by our E-Z Pay program to your credit card.

2. **DUES.** Your dues, unless prepaid, must be paid through the E-Z Pay program each month of your MEMBERSHIP due on the date designated by Jessy's. You agree to sign and deliver such further documents as may be necessary to set up the payment of your dues and other charges through VISA/MASTERCARD. You authorize Jessy's to debit your VISA/ MASTERCARD for collection of dues. Any change in your Credit card account information must be notified immediately in order to charge the new account and prevent charges to the old account. If you have prepaid your dues, and if you choose to prepay again at the end of a prepaid term of MEMBERSHIP your new prepaid amount will reflect a discount of 5% of your dues.

3. No refunds shall be made for MEMBERSHIP dues. Under no circumstances will refunds of dues be made retroactively due to failure to not use Jessy's on a monthly basis.
